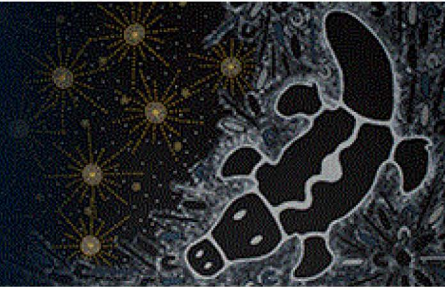

I hope all is well with you? After discussions with Bruce, I believe you are the point of contact in relation to the above referral. I understand that the City of Melbourne has raised concerns regarding parcels delivered to 76 Canning Street, addressed to 114 apartments in that building. These articles were delivered by Australia Post, but have not been distributed to the addressees, apparently on the basis of those concerns.

We have corresponded with the City of Melbourne regarding our concerns – that their actions have delayed and interfered with the delivery of mail as addressed. We also intend to update our customer regarding the situation.
